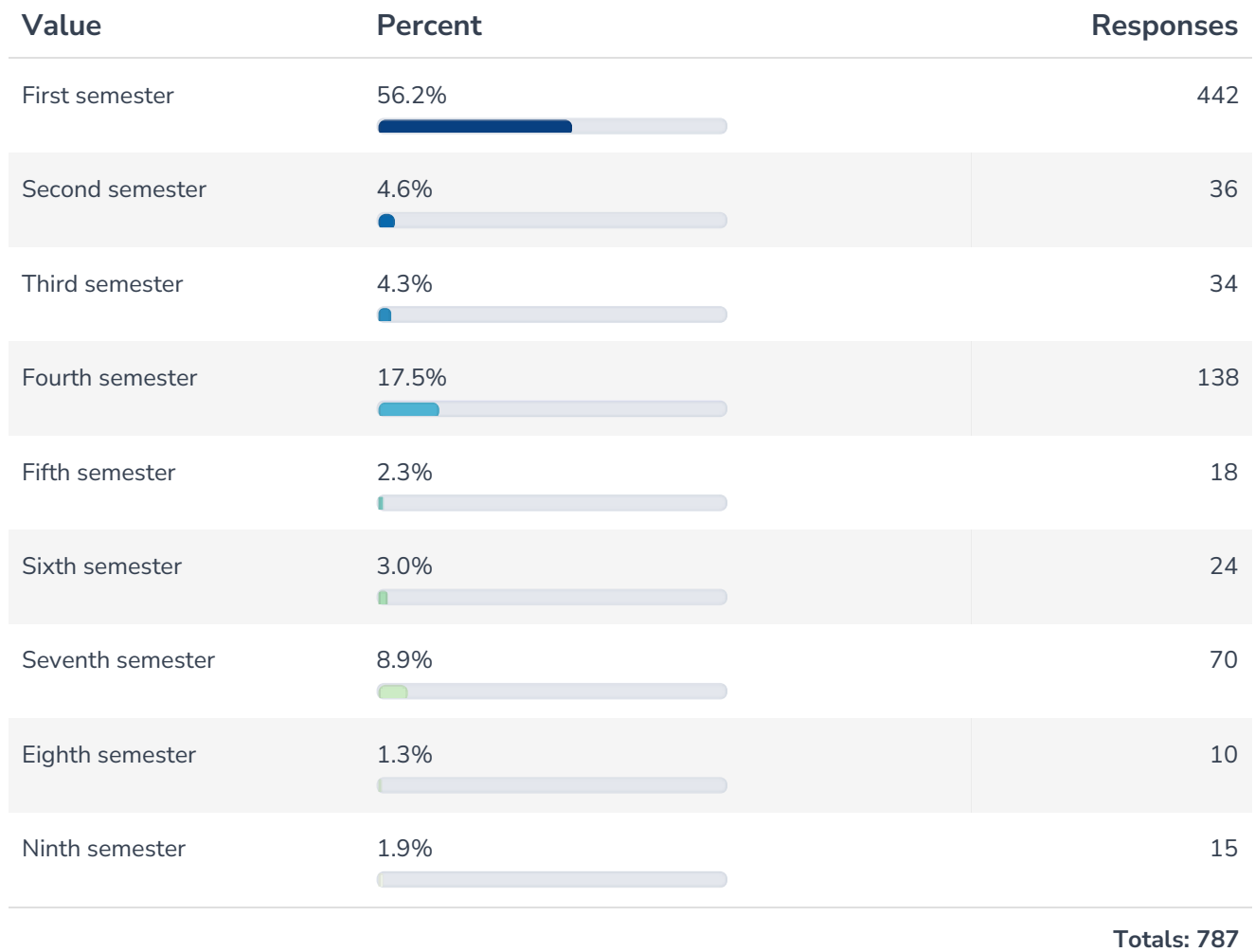

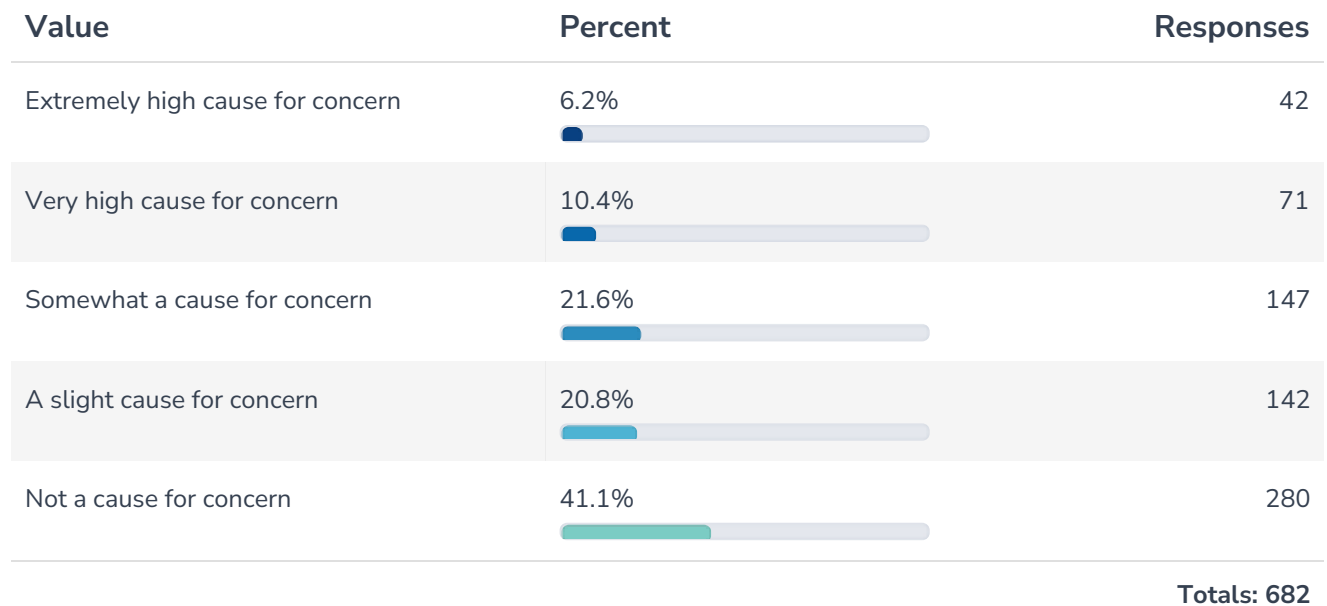




How many packs of cigarettes do you smoke in a typical week?
